#### Study Circle Reporting.....

**45th Study Circle:** The 45th study circle of universal briefing took place on 30th August, 2025 at 7.30 pm. The speaker for the session was Dr Snigdha Naskar, Assistant Professor, Department of Library and Information Science, Rabindra Bharati University and the President of the session was Dr. Sanat Bhattacharya, Assistant Librarian, Visva Bharati, West Bengal. The topic of the study circle was "Human Library: journey to a new paradigm".


The speaker presented a thought-provoking analysis of a global trend that has gained momentum over the past two decades and is now emerging in our country. She began her discourse with a compelling excerpt from 'Hamlet', followed by a quote from 'Hind Swaraj' by Mahatma Gandhi, setting the stage to explore the more concerning aspects of the Human Library movement. While acknowledging the wellintentioned origins of the initiative, which was introduced to address violence and social exclusion by encouraging open dialogue, Dr. Naskar raised critical concerns about the unintended consequences of this format. She pointed out the alarming tendency to commodify individuals as "human book", reducing their human experiences to consumable narratives. Furthermore, she addressed significant issues related to intellectual property rights, privacy, and data protection, all of which become especially vulnerable within the context of these events. The speaker also shed light on the growing presence of the Human Libraries in Kolkata. She stressed the importance of ethical implementation, raising concerns about privacy, rights, and the commercialization of personal stories. While hopeful that the initiative could promote empathy and social awareness, especially for marginalized groups, she emphasized that this must not come at the cost of participants' dignity and rights. Concluding her address, the speaker stressed that the Human Library, however well-intentioned, should not be misconstrued as an extension of traditional libraries, as it does not align with its fundamental principles.










#### **UB Endeavour**





#### Commonwealth Scholarships

The Commonwealth Scholarship provides students from any Commonwealth country, including India, an opportunity to pursue various degree programs in the United Kingdom (UK). Granted since 1960 it is fully funded by the UK Foreign, Commonwealth & Development Office (FCDO) and falls within the Commonwealth Scholarship and Fellowship Plan (CSFP). While there is no dedicated Library and Information Science scholarship, however, it is an eligible discipline and falls within the scope of the developmental themes covered under the scholarship, such as access, inclusion, and opportunities. The field of study selected must contribute to the development of India. Students who are Indian citizens may apply through the Commonwealth Scholarship Commission's Online Application System as well as on the scholarship portal of Ministry of Education, India.

Candidates must have an offer for admission from a UK university partnered with the Commonwealth Scholarship Commission (UK) for intake at the time of applying and to be considered for this scholarship. There are multiple master's and PhD program scholarships available with varying eligibility and benefits. General financial benefits include approved airfare from the scholar's home country to the UK and return at the end; approved tuition fees; stipend/living allowances; study travel grant; and child, disability, and family allowances (if applicable).

The Asiatic Society, in collaboration with IIT Kharagpur, IIT Delhi, and CDAC, has launched a pioneering



initiative to digitize, transcribe, and translate Bengal's ancient manuscripts using Al and machine learning. Hyperspectral imaging will aid in recovering faded texts, while advanced algorithms will decode codified scripts. At a recent stakeholders' meeting, institutions like Calcutta University, Visva-Bharati, WB State Archives, Kolkata Port Trust and Victoria Memorial Hall pledged support. With over 50,000 manuscripts at stake, the project aims to preserve and democratize India's intellectual heritage, making it accessible

to scholars, students, and the public. For details <u>click here</u>

Banaras Hindu University VC Prof Ajit Kumar Chaturvedi visited the Sayaji Rao Gaekwad Central Library, urging greater use of technology to modernize and enhance student access. He reviewed services for visually impaired students, including audio books via Kibo scanners and Braille editions, benefiting over 200 students. The VC also examined rare manuscripts and proposed creating an online catalogue to showcase BHU's literary heritage globally. With over 12,500 manuscripts, 7,281 are preserved in the library. His visit marked launch of RFID technology, streamlining book issuance and returns for the hundreds of students who use the library daily.

The Family Court Bar Association, Nagpur inaugurated a Library and E-Library to support advocates with modern legal resources. Justice Abhay Mantri emphasized reading's role in legal excellence. The initiative, launched after 27 years, includes digital tools and rare manuscripts, aiming to empower young lawyers and improve access to legal knowledge.

Bihar's Information Technology Department is now a part of the Mukhyamantri

Digital Library Yojana, a government initiative aimed at expanding digital access to educational resources across the state. The department is asking district magistrates and education officers to identify and allocate 300–400 square feet of space at Block Resource Centres (BRCs). These spaces will serve as digital libraries, providing students and citizens with access to e-learning tools, books, and internet-based educational services. This move reflects Bihar's push to modernize education infrastructure and bridge the digital divide, especially in rural and semi-urban areas.

Sci-Hub was a lifeline for researchers, especially in underfunded institutions lacking subscriptions to expensive journals. The Delhi High Court has ordered the blocking of Sci-Hub, Libgen, and related shadow libraries in India, following a copyright infringement case filed by major academic publishers like Elsevier, Wiley, and the American Chemical Society. These platforms were accused of distributing copyrighted research papers without authorization, violating previous court undertakings.

Prof. Ajay Pratap Singh, Director General of RRRLF welcomed all participants of 53rd Capacity Building Program of National Mission on Libraries which was organised at Raja Rammohun Roy Library Foundation, Ministry of Culture, Govt. of India. They have learned integrated library management software (ILMS) for automated library operations. As part of this Capacity Building Programme for Public Library Personnel, participants visited the National Library. They explored different sections, discovered preservation techniques, and experienced the library's vast treasures.

The Directorate of Library Services, Government of West Bengal celebrated Public Library Day on 31 August 2025 with a state-level program at Dhono Dhanyo Auditorium, Alipore, Kolkata. The event featured beautifully designed tableaux, venue branding, and cultural presentations highlighting the role of libraries as vibrant community hubs. The celebration underscored the state's commitment to promoting public libraries as centres of knowledge, inclusion, and lifelong learning, while encouraging greater public awareness and participation in library services across West Bengal.

#### Digital Democracy: Internet Archive Becomes a Federal Library

The Federal Depository Library Program (FDLP), managed by the US Government Publishing Office (GPO), has provided free access to official federal documents since its establishment in 1813. Today, there are 1,150 depository libraries located across all 50 states, with most operating as physical libraries. This initiative continues to play a crucial role in ensuring that the public can easily access government information.



The Internet Archive has officially become a federal depository library, which allows it to offer free access to important resources such as bills, laws, regulations, presidential documents, studies, and more. As a nonprofit organization, this new role aligns seamlessly with its mission to ensure that knowledge remains accessible to everyone. This expansion into the Federal Depository Library Program underscores the Archive's commitment to serving

the public and promoting equitable access to information.

Since 2016, the Government Publishing Office (GPO) has been a strong advocate for digital preservation, and their efforts have gained momentum in recent months. In a move to expand the Federal Depository Library Program (FDLP), congressional members can now designate up to two qualified libraries. Recently, California Senator Alex Padilla nominated the Internet Archive for this designation. With its commitment to removing barriers, the Internet Archive is poised to enhance access to federal government publications for communities both nationwide and globally. As technology advances, the Internet Archive stands at the forefront of online library services, making it a valuable addition to the Federal Depository Library Program.

# Library in Focus

#### The 116-year-old The Boys' Own Library in Kolkata faces an uncertain future



In Kolkata, every turn, every locality awaits with a glimpse of history. One such hidden gem is the century-old The Boys' Own Library and Young Men's Institute in north Kolkata's Goabagan. Three school-going teenagers, Krishna Prasanna Ghosh, Jiban Krishna De and Prodyut Kumar Rudra founded the Boys' Own Library on 1st May 1909, with a handful of only 20 books and a wobbly almirah. Dr. Girish Chandra Dutta, an eminent physician generously accommodated the library at free of rent in his residential house at 12, Ram Narayan Bhattacharya Lane, Kolkata- 700 006. Initially, the total number of members was eight, and the monthly subscription was two annas. There was no admission fee of deposit money, neither the library had any written constitution. By 1911, as the number of members increased, it became necessary to formally frame and write down the Library Rules. The Boys Own Library also contributed significantly to the

Library Movement in Bengal. From 1915 onwards, the library underwent several shifts. In 1915 it was shifted to 7/3 Beadon Street, Kolkata-700006. In 1917, it again removed to a rented room at 71, Masjid Bari Street Kolkata- 700 006. In 1918, the Memorandum and the Articles of Association was registered. Being satisfied with the activities of the Library, the Calcutta Corporation sanctioned an annual grant of Rs. 75/- in 1919. In 1920, the library was again shifted to 12, Ram Narayan Bhattacharya Lane, Kolkata-700 006. In 1936, the library moved to 76/2 Bidhan Sarani, Kolkata-700 006. Its current location is 2, Boys' Own Library Row in Goabagan, shifted 1968. Six years before the shift, in 1962, Scientist Satyendra Nath Bose laid the foundation stone of the building, and the three-storey space was inaugurated by union education minister Dr. Triguna Sen, with novelist Tarashankar Bandyopadhyay in attendance at the event.

In 1912, 'Balya Pratibha', a manuscript Bengali magazine was started by the library with the aim of giving the members an opportunity of improving their writing skill. A 'Book Committee' was formed in 1911-12 and the library activities were extended, with the formation of a Debating Section. Following the student's taboo of reading Bengali fictions and dramas in those days, the eminent dramatist D. L. Roy presented a copy of "Mewar




Patan" with an endorsement on the cover, in the author's own handwriting. This complimentary copy of "Mewar Patan" was however kept in the library shelf after a marathon discussion in the Executive Committee. The Institution celebrated its Silver Jubilee in May 1934. By that time, it possessed 2123 volumes of English books, 2776 Bengali Books, 73 volumes of English and 394 volumes of Bengali Magazines. The Children Section of the Library was started in 1939-40. In 1949, a new department called the "Vishesh Bangla Sahitya Bibhag" was commenced as an aid to the research scholars and serious readers in Bengali language and literature. In May 1981, the Kolkata Municipal Corporation appreciated the activities of the library, by naming its front street as "Boys' Own Library Row. According to an 81 years old member "history and heritage alone is often not enough for survival in modern times. He worries about the uncertain future of his beloved institution due to the lack of funds. In fact, almost all those who oversee the library today have somehow kept this library alive by working free of cost, voluntarily. There is constant financial stress, but present members of the library are trying to fix a steady budget.

In course of 100 years of struggle in the field of education, culture and library movement, the Boy's Own Library & Young Men's Institute is functioning as a non-communal and non-political organization, committed towards cultural inter-action and development of the library movement in West Bengal. The library now awaits not just for readers also for revival.
